

Policy for Shirts Allowed at Founders Cup

WAKA Founders Cup Tournament Player Shirt Policy

While participating in the Founders Cup, players must wear and display WAKA T-shirts that are obtained from WAKA. They may wear either the *WAKA Gildan Issued Cotton* player shirt in the color assigned to the team accepting the invitation to this tournament, or *WAKA Performance Athletic Wicking shirt* purchased from the WAKA store and approved for use in tournament play. The requirements are detailed here.

The following shirts are permitted to be worn during tournament play:

- 1) *WAKA Issued Gildan Cotton player shirt* in the color assigned to the team accepting the invitation to this tournament
- 2) *WAKA Performance Athletic Wicking shirt* purchased from the WAKA Store.
- 3) Specifics outlined below:
 - a) All registered players on any one team must wear shirts of the same color.
 - b) Teams that wish to have ALL players wear *WAKA Performance Athletic Wicking shirts* may change their team color to one of the 10 colors available. Every registered player on the team must wear the same color WAKA Performance Athletic shirt during tournament play. Teams changing their shirt color from the color assigned to the team accepting the invitation to this tournament [during regular season play] must submit their tournament shirt color to tournamentshirts@kickball.com no later than August 15, 2008.
 - c) Teams that wish to have SOME players wear *WAKA Performance Athletic Wicking shirts* and others wear *WAKA Issued Gildan Cotton player shirts* may do so ONLY if *WAKA Performance Athletic Wicking shirts* are available in the color assigned to the team accepting the invitation to this tournament. The same color *WAKA Performance Athletic Wicking shirt* can be purchased from the WAKA store for those players that wish to wear that style of shirt.
 - d) If no team color is submitted to tournamentshirts@kickball.com teams must wear their *WAKA Issued Gildan Cotton player shirt* in the color assigned to the team [during regular season play] accepting the invitation to this tournament
 - e) Teams may alter *WAKA Performance Athletic Wicking shirts* and/or *WAKA Issued Gildan Cotton player shirts* as they see fit, but may NOT alter any logos or text pre-printed on the player shirt at the time of distribution [examples include left chest logo and text, bar logo, play kickball logo, or any division name and text on the back top of shirt]. Alterations and/or additions to shirts may not contain reference or implication to political agenda, issue, candidates, elected officials, religion, or overt alcohol, drug, or sexual reference. WAKA Central retains the ultimate right to reject or accept alterations and/or additions to shirts.
 - f) All registered players on any one team [at the check-in desk at the tournament] must present their shirt for view
 - f) Teams are not allowed to wear shirts [of any kind] that have been printed by a third party.
 - g) Players failing to meet any of the above requirements will not be eligible for play.
